It is my responsibility to understand the level of difficulty involved and for knowing my own ability and the appropriate food, clothing and equipment I may need.

2. My participation in this trip is entirely voluntary. By undertaking to participate in this trip, I expressly acknowledge that such participation involves risks and obligations that are impossible to predict. These may include, but are not limited to, the risk of loss or damage to my personal property and the risk of sickness, personal injury or death while participating in this trip.

I, hereby exempt and release Evergreen Audubon, its directors, officers, agents, employees, leaders, instructors or volunteers, from any and all liability, claims, demands, actions or causes of action whatsoever arising out of any damage, loss, injury or death to me or my personal property while participating in any aspect of this trip, irrespective of the cause of such damage, loss, injury or death.

It is expressly understood that all such potential losses, damage, or injury are not known and cannot be determined as of the date of this Release, but it is my express intent that this Release apply to any and all such unknown damage, loss or injury. I have thoroughly read and understand the statements and conditions stated herein and agree to the terms of this Release, as noted by my signature below.
